Brett Freyder, being first duly sworn upon oath, deposes and states as follows under penalty of perjury:


1. I am over the age of eighteen years, of sound mind, and competent to testify to the following facts based on personal knowledge.
2. I was present on Wednesday, November 10, 2010 as an observer at Table 5. While observing precinct 5-510, I noticed a discrepancy in the total of votes cast and the total of votes for Lisa Murkowski. The printout of this district reported a total of 305 write-in votes. After we processed the ballots, an election worker counted them and the recorded total was 322. An increase of 17 Murkowski votes.
3. I was present on Friday, November 12, 2010 as an observer at Table 2.
 - a. While observing precinct 2-250, we had one Miller write in vote. When the DOE came to do the paperwork, they did not include this vote in the ballot counts.
 - b. While observing precinct 36-655, there were 16 write-in paper ballots, 3 misspelled 13 correct. It also contained 36 touch screen votes all spelled correctly and spaced the same. This was unusual, as touch screen votes normally appear with the same mistakes, and anomalies as paper ballots.
 - c. While observing precinct 37-726 I saw that the final number of write-in votes was 5 over what the DOE paperwork showed as the total casts.
4. I was present on Friday, November 12th and personally heard Gail declare the following misspelled votes for Lisa Murkowski:

5. I was present on Sunday, November 14, 2010 as an observer at Table 15.
 - a. Our table reviewed District 15 92-970, which was a recount from November 13, 2010. I was told that this was due to a lost envelope. This made me question who had the envelope and when it was lost.
 - b. After District 6, 97-A I asked hand count staff Wilcox and Davis to place no oval ballots in box #2 because they were placing them in box #4. They said "that's just how we do it".
 - c. For District 32 "Question" N-21 I was told this was a recount of a recount because numbers were not recorded.
 6. I was present on Monday, November 15, 2010 as an observer at Table 15.
 - a. While observing District 8, Absentee ballots, there was 1 write-in vote for Miller was called challenged, counted but not recorded on the numbers paperwork. These ballots also came in four envelopes marked "District 8 93-900 absentee 1 of 2", "District 8 93-900 absentee 2 of 2", "District 8 absentee 1 of 1 (334) A", and "District 8 absentee 2 of 2 (3) A" There was also a possible missing envelope because I did not see any District 8 absentee bag 1 of 2 (3) A. I was told "Don't worry it's just miss-marked".
 7. I was present on Sunday, November 14 – Monday, November 15, 2010 and personally heard Gail declare the following misspelled votes for Lisa Murkowski:
