AFFIDAVIT OF JODIE PESSOLANO

JODIE PESSOLANO, being first duly sworn upon oath, deposes and states, under penalty of perjury:

- 1. I am over the age of eighteen years, of sound mind, and competent to testify of the following facts based on personal knowledge:
- 2. I am an observer for Joe Miller for the count of ballots now taking place for the election for U.S. Senate. The following are some of the several discrepancies/inconsistencies that I witnessed during my service:
- 3. I began serving as an observer on Monday November 8. I observed the opening of absentee ballots from their original individual envelopes as they were placed in large envelopes, which were sealed with signatures across the flap.
- 4. Some of these were faxed ballots, and were transcribed to official ballot forms in order to be run through for a count. One in particular caught my eye. Ballot number 106 had a write-in spelling that appeared at first glance to read, "Lisa Murkooski". With a closer look, it could be construed as "Lisa Murkoaski". With an even closer look, the letter after the "o" can be interpreted as a sloppy cursive "w" with a closed loop, reading, "Lisa Murkowski". As two workers discussed it (and worked through the spelling roughly as I described), I put in my opinion that it could be interpreted in any one of the three ways. The ballot was transcribed as "Lisa Murkowski". I was told lawyers would later review this, and that faxed ballots would be kept with the transcribed ballots for review. Yet on Monday November 15, as I viewed one faxed ballot, I was told by Marcia Wilcox at Table 12 that only originals could be viewed, but not the transcribed ballots.
- 5. On Wednesday November 10 I began my first day observing the sorting of ballots into the 5 categories. It is my recollection that ballots with Murkowski written-in but no oval filled were counted for Murkowski on that day. I recall one ballot without an oval filled in and Lisa Murkowski written-in counted for Murkowski. I remember the Miller lawyer exclaiming, "no oval!" (After that date all such ballots that I witnessed were not counted for Murkowski). I do remember being surprised the following day to see such ballots no longer counted for Murkowski by the director.
- 6. Also on November 10 I witnessed one ballot that read 'Mrkwsk'. This was counted for Murkowski. The Miller lawyer reviewing my challenges was incredulous, stating, "no vowels!" Yet on Sunday November 14 I witnessed a ballot reading "Merksk" categorized by the Director of D.O.E. as "not counted" (I believe this was District 3, A Count, Questioned Ballots).

- 7. I witnessed votes for "Lisa M." on the 10th, and I believe that they were counted that day (cannot recall for sure a review of the challenged but counted ballots should reveal this). I do know that after that day I have not seen them counted.
- 8. Around 1PM on Friday the 12th I worked table 12 with Florence Tong and Isaac Kearns as election workers, and Bonnie Jack as Murkowski observer. The election workers placed challenged ballots in box 4 that had no clear misspellings and only marginal problems with legibility. I told them on several occasions that I had no objections to these ballots, and in fact thought that they were legitimate Murkowski ballots. They said that the reviewers could decide that.
- 9. In the mid-afternoon of the 12th I returned to the D.O.E. annex at Mendenhall Mall to witness more absentee ballots opened and placed in bulk envelopes. One ballot in this batch (#61) appeared to read, "Murkowiaki". A supervisor told me that the "ia" appeared to be a cursive "s" and recorded it for Murkowski. I acknowledged this as a possibility, but objected to assuming it to read Murkowski. I was told, "You can object all you want, this is what we are recording". Again I was told that the original and transcribed ballot would be available for comparison and review in the future (notwithstanding my experience to the contrary on the 14th as previously stated).
- 10. On Saturday November 13 I worked table 3 with election workers Mary Reeves and Suzanne Clover, with Ben Brown as the other observer. This team separated write-ins prior to sorting in boxes. With the separate pile of write-ins, Mary proceeded to flip the ballots into box 3 at a pace quicker than one per second. Additionally, she continually struck me near the left eye with the corner of each ballot (being near-sighted, I needed to have my head over the sorting box). I explained my near-sightedness problem, and Ben commented that, "Jodie, I'm not worried about your near-sightedness - I'm worried that you may soon be non-sighted!" I had to protect my eye with my left hand as I observed the ballots, and frequently said, "stop!", when I saw a problem and didn't have time to see the ballot before the next one struck me on it's way to the box. After the completion of a precinct, I asked if they could slow down for me. Ms. Clover bragged that, "we've been told that we have the fastest table". I was told that others before me had no problem, and that I should probably find another table if I couldn't keep up. (I later spoke to two other Miller observers who told me they had the same problem with these ladies). I told this to some of the Miller staff. I assume they spoke to these ladies, as the next day they were more considerate of my need to have time to observe the ballots.
- 11. On November 14 I witnessed a vote that had an oval filled for McAdams and for write in (Murkowski). The oval for McAdams was crossed out, and the vote was considered by the Director to be a vote for Murkowski.
- 12. I observed on at least two occasions ballot packages opened that did not have signatures across the flap.

13. Finally, I want to say that at least two times I was told by election workers that "voter intent" was what mattered. On November 10 Julie Franklin told me that, "It's voter intent that matters" after a particular challenge. On November 15 Marcia Wilcox said something to the effect that "this will be referred to the law of voter intent".

Further affiant sayeth naught.
